DLSA adalat: 8 mental health centre patients discharged

Eight residents of the Pe-roorkada Mental Health Centre who were fit for discharge were sent to live with their families or in psychosocial institutions following an adalat conducted by the District Legal Services Authority (DLSA) as part of Manonjay-Nilavu schemes of the National Legal Services Authority (NLSA) and the DLSA for rehabilitation and repatriation of the mentally ill and the Harmony Hub programme for resolving issues in relationships through mediation.

The adalat held recently was presided over by S. Shammad, senior civil judge and DLSA secretary. Seven DLSA panel lawyers assisted with the adalat.

In many cases, families were reluctant to take back the residents, most of them men. They claimed that once back, the men would stop taking medicines and become violent with them. Others claimed they had no one ready to take care of the patient full time.

Southern Railway allots new train stops

The Southern Railway, which had discontinued a slew of stoppages during the post-COVID-19 period, is now restoring or allowing permanent additional stoppages for trains across the State. At least a dozen trains have been provided new permanent stoppages in the last few weeks.

The trains included Mangaluru Central-Kanyakumari-Mangaluru Central Parasuram Express at Vaikam Road from November 1, Nilambur Road-Thiruvananthapuram North Rajya Rani Express at Karunagapally from October 30, Thiruvananthapuram North-SMVT Bengaluru-Thiruvananthapuram North Humsafar Express at Kayamkulam Junction from November 1, Guruvayur-Madurai Junction Express at Perinad from October 22, Thiruvananthapuram Central-Kannur Jan Shatabdi Express at Changanassery from October 9, Nagercoil Junction-Kottayam Daily Express at Oachira from September 3, Ernad Express at Sasthamkotta from September 4, and Palaraui

vi Express in Irinjalakuda from September 8.

Further, Chennai Egmore-Guruvayur Express was allotted stops at Hari-pad, Chirayinkeezu, Kadakkavur, and Paravur recently. The majority of the special trains that pass through the Changanassery railway stations are now allotted stoppages. There are around 50 to 100 special train services during the festival season, and during the Sabarimala pilgrimage season it would be around 300 services. All these trains now have stoppage at Changanassery.

Sources in the Railways said the spurt in allotting permanent additional stoppages is due to political pressure rather than operational reasons. The majority of the discontinued stops for trains were between midnight and 4 a.m. For instance, Irinjalakuda has lost the midnight stop of trains like the Malabar Express and the Mangalore Express, which have not been restored until now despite improved footfall and revenue. As per the train halt policy, a stop is provided for trains based on the revenue generated from each station.
