# Rifts emerge in Twenty20 after joining NDA

Fissures have begun to appear in Twenty20, the Ki-tex group-backed political outfit, just a day after it joined the Bharatiya Janata Party (BJP)-led National Democratic Alliance (NDA) with both the Congress and the CPI(M) claiming that disillusioned party workers and leaders, including elected representatives, are set to defect to their ranks in the coming days.

At a press conference held alongside Kerala Pradesh Congress Committee (KPCC) vice-president V.P. Sajeendran, Twenty20's former Vadavucode block panchayat member Raseena Pareeth announced the exit of a group of members from the party. She accused the leadership of turning the outfit into a re-

cruitment agency for the BJP. "All along, it was said that the party would neither join the Right nor the Left, but would dissolve if forced into such a situation. There will be mass resignations and an exodus from the party, including elected representatives, in the coming days," Ms. Pareeth warned.

Mr. Sajeendran described the decision to join the NDA as the "end game" for Twenty20 State president Sabu M. Jacob. He alleged that consultations with the BJP's national leadership had taken place even before the local body polls, betraying the trust of voters. The BJP is using Twenty20 as a shortcut to breach the Kunnathunadu constituency, which has a significant population of minorities and Scheduled Castes, he alleged.

Twenty20 vice-presi-

dent V. Gopakumar dismissed the resignations as inconsequential, asserting that all mandalam presidents and State committee members remain firmly with the party.

## CPI(M)'s claims

In a separate press conference, CPI(M) district secretary member K.S. Arunkumar and Kolan-cherry area committee secretary K.K. Elias claimed that disgruntled Twenty20 members would join their party in large numbers.

The latest developments have placed the United Democratic Front (UDF) in a difficult position in the Vadavucode-Puthencruz panchayat, where it came to power with the support of two Twenty20 members. In the 17-member council, the Left Democratic Front (LDF) emerged as the single largest bloc with eight

members, compared to seven from the UDF.

The CPI(M) was quick to highlight this and demanded that the Congress relinquish power. However, the Congress and Twenty20 adopted divergent positions, though both effectively preferred to maintain the status quo. The Congress claimed that Twenty20's elected members would align with it, while Twenty20 placed the responsibility on the Congress to decide whether to remain in power or resign.

K.M. Divya, one of the two elected Twenty20 members in the Vadavucode-Puthencruz panchayat, stated that she would abide by the party leadership's decision. She emphasised that party president Sabu M. Jacob would never take a decision against the interests of the people.

# Kerala declares *Bacillus subtilis* 'State microbe'

*Bacillus subtilis*, a type of probiotic or "good" bacteria found widely in the environment and naturally in the gut of humans as well as in fermented foods, will now be deemed the State Microbe.

Chief Minister Pinarayi Vijayan declared *B.subtilis* the State Microbe at a function held here on Friday, making Kerala the first State in the country to offi-

cially declare its own State microbe. Mr. Vijayan was dedicating the Centre of Excellence in Microbiome (CoEM), established by the government, to the people.

The CoEM was set up with the objective of scientifically studying the role of microorganisms in health, environment and sustainability and for translating research outcomes for the benefit of society.

The Chief Minister added that *B.subtilis* is useful in disease control and in

increasing agricultural productivity and that products being developed by various universities based on this microorganism would become a major economic asset for the State.

CoEM, in collaboration with the Kerala Development and Innovation Strategic Council (K-DISC), is the first institution in the country to bring microbiome-based translational research across multiple sectors, including human health, nutrition, immuni-

ty, agriculture, fisheries, and environmental conservation under one umbrella.

CoEM will work on harnessing microbiome-based research outcomes for the development of microbial technologies across sectors.

CoEM exchanged Memoranda of Understanding (MoUs) with representatives of the Kerala Startup Mission and Amrita School of Biotechnology for future collaborations.

# Nod for course on water hyacinth

The Ministry of Environment, Forest and Climate Change (MoEFCC) has approved a new Green Skill Development Programme (GSDP) course focused on value addition to water hyacinth.

The course, titled 'Water Hyacinth (Value Added Products) Entrepreneur', has been developed in line with the National Skill Qualification Framework, and the guidelines of National Skill Development Agency and the Ministry of Skill Development and Entrepreneurship. It will be offered in Kerala through the Kerala State Council for Science, Technology and Environment (KSCSTE)-Malabar Botanical Garden & Institute for Plant Sciences in Kozhikode.


The 390-hour residential programme combines theory, practical training and on-the-job exposure with the objective of equipping youth with employable skills and promoting self-employment through environmentally sustainable enterprises. It was developed by a multidisciplinary team led by Prof. G. Nagendra Prabhu

The police have arrested a man in connection with the death of his one-year-old child in suspicious circumstances earlier this month in Neyyattinkara.

Shijil, the accused, has reportedly confessed to causing the child's death by hitting him in the abdomen. Ithan, the son of Shijil and Krishnapriya Kanjiramkulam, had collapsed and died on January 16.
