Two die of suspected food poisoning

The duo, who ate at a restaurant in Vizhinjam on Monday, fell ill on way back; no conclusive evidence found in post-mortem; restaurant closed

Two persons of a family, natives of Nilamel in Kollam, are suspected to have died of food poisoning.

They were identified as Shaji, 42, and his mother-in-law, Rasheeda Beevi, 58. Shaji's wife has also been hospitalised, initially at the Kollam Government Medical College Hospital (MCH) and later referred to the Government Medical College Hospital, Thiruvananthapuram.

According to reports, late night on Monday, the family of six had come from Nilamel to a popular restaurant at Vizhinjam in Thiruvananthapuram, which specialises in sea-

food delicacies, for dinner. Shaji and Rasheeda Beevi became unwell on the way back, near Attigal.

They were initially admitted at the Kollam MCH and as their condition became serious, were referred to the Thiruvananthapuram MCH, but they could not be saved.

Three others in the family, including two children, have not exhibited any signs of food poisoning.

The post-mortem report has not given any conclu-

sive evidence regarding food poisoning or possible food allergy and hence detailed chemical analysis report is awaited.

The Vizhinjam police ordered the restaurant to be closed as soon as the news broke. On Tuesday morning, the food safety wing swung into action and conducted a detailed examination of the restaurant and its premises. They have collected samples of fish as well as that of drinking water.

The police said that scores of people had had dinner at the same restaurant that evening.

While members of Shaji's family suggested food poisoning, no one else has raised any complaints so far.

School bus loses control, falls into canal at Mottakkavu

State Institute for Animal Diseases gets new lab complex

Minister for Animal Husbandry and Dairy Development J. Chinchurani will inaugurate a new Toxicology Laboratory Complex and Toxin Residue Analysis Unit set up using funds from the Rebuild Kerala Initiative (RKI) under the Kerala Chicken Project, at the State Institute for Animal Diseases (SIAD), Palode, on Wednesday.

D.K. Murali, Vamanapuram MLA, will preside over the function.

The Toxicology Division of SIAD, the State-level referral laboratory of the Animal Husbandry department, is responsible for

testing animal deaths caused by poisoning. It is also responsible for identifying mycotoxins present in animal feed.

The new laboratory complex has been readied using ₹4.5 crore.

"This significant infrastructure upgrade includes a subdivision named the 'Toxin Residue Analytical Laboratory', funded by the Rebuild Kerala Initiative (RKI) as part of the Kerala Chicken Project. This laboratory features enhanced facilities to conduct pesticide and antibiotic residue testing in food of animal origin and strengthens Kerala's commitment to food safety and animal health," said a press release.

100 BUDS institutions to be raised to model status, says Minister

A hundred BUDS institutions will be upgraded to model institutions this year, Minister for Local Self-Government M.B. Rajesh has said. He was speaking after performing the State-level inauguration of Kudumbashree model BUDS institutions and the Chirakul scheme for adolescents in such institutions here on Tuesday.

The Minister said 10 select institutions from Malappuram, Palakkad, Thrissur, and Alappuzha districts were being announced as model institutions in the first phase. Forty-one institutions have

been selected as part of the second phase.

The government had given approval for spending ₹4.7 crore on infrastructure development and providing equipment for children in 29 select BUDS institutions functioning under the Kudumbashree, Mr. Rajesh said.

According to revised guidelines, a unified training model would be implemented under the umbrella of the Kudumbashree for teachers and ayahs in these institutions.
