## 238 bird species spotted in district during Great Backyard Bird Count

THIRUVANANTHAPURAM

A total of 238 bird species were documented across Thiruvananthapuram district during the Great Backyard Bird Count (GBBC), an annual four-day global citizen science initiative held from February 13 to 16.

Endemic species such as Grey-fronted Green-Pigeon, Malabar Imperial-Pigeon, Malabar Grey Hornbill, Malabar Flameback, Malabar Parakeet, Malabar Woodshrike, Malabar Starling, Nilgiri Flowerpecker were listed from various locations, mostly in the forest fringe areas.

The local effort by approximately 125 volunteer birders, resulted in 1,160 individual observations submitted from across the

district, A.K. Sivakumar, Senior Education Officer, WWF-India, and GBBC coordinator of Thiruvananthapuram district, and WWF-India State director Renjan Mathew Varghese said in a statement. The district-wide initiative was bolstered by the Campus Bird Count (CBC), a specialised sub-event coordi-

nated by the WWF-India Kerala State Office. This component engaged 110 birders across 11 educational and institutional campuses.

### Species observed

Migratory birds including Indian Pitta, Indian Golden Oriole, Ashy Drongo, Indian Paradise Flycatcher,

Brown Shrike, Orange-headed Thrush, Asian Brown Flycatcher, Brown-breasted Flycatcher, Blue-throated Flycatcher, Blyth's Reed Warbler and Rosy Starling were observed from across the district.

Other species that were sighted included the Fork-tailed Drongo cuckoo, Crested Hawk Eagle, Barn Owl, Black-naped Monarch and the Lesser Yellownappe.

CBC is a grassroots-level collaborative initiative spearheaded by representatives of campuses with expert support that encourages observing and documenting the birds found within their campuses and recording them on global citizen science platforms.

## SIR: Thiruvananthapuram has a little over 25 lakh voters

Thiruvananthapuram district has a little over 25,26,325 voters in the final electoral roll published by the Election Commission of India (EC) on Saturday following the Special Intensive Revision (SIR).

This number is 3.21 lakh lower compared to the October 27, 2025, list which had 28,47,907 voters, but higher by 86,083 voters compared to the draft electoral roll published on December 23, 2025. In all, 24,40,242 voters had figured in the latter list.

Of the 25,26,325 voters in the final roll, 13,21,354 are women, 12,04,917 are men and 54 are transgender voters. Thiruvananthapuram has the highest

number of voters in the latter category in the State. The EC formally published the final rolls following the SIR exercise which kicked off in Kerala with a house-to-house enumeration phase on November 4, 2025.

**Constituency-wise list** Among the 14 Assembly constituencies, Kovalam has the highest number of voters (1,99,738), while Thiruvananthapuram with 1,57,453 voters, has the lowest.

The latest voter popula-

tion in the 14 Assembly constituencies in the district are as follows: Varkala (1,82,681), Attingal (1,97,231), Chirayinkeezhu (1,94,981), Nedumangad (1,97,007), Vamanapuram (1,87,118), Kazhakkuttam (1,62,723), Vattiyurkavu (1,63,063), Thiruvananthapuram (1,57,453), Nedom (1,69,371), Aruvikkara (1,80,182), Parassala (1,93,742), Kattakada (1,75,589), Kovalam (1,99,738) and Neyyattinkara (1,66,246).

Although the SIR exercise is over, voters can still add their names to the EC roll, election officials stated.

Election rules stipulate that names can be added to the electoral roll till the last day of filing nominations for the elections.

## Keralite injured in blast in Malaysia airlifted to State

Dhaneesh Ravi, 31, a native of Thiruvananthapuram, who has been undergoing treatment in Malaysia since last December following burns, was flown to Thiruvananthapuram from Kuala Lumpur after the intervention of NoRKA-Roots, the State government agency that works for the welfare of non-resident Keralites.

Mr. Ravi, a resident of Sreekrayam, arrived here on Friday midnight and was shifted to Thiruvananthapuram Government Medical College Hospital (MCH) for further treatment. Mr. Ravi, who sustained more than 53%

burns, had been undergoing treatment at the University of Malaya Medical Centre since last December.

In a similar incident, a woman named Mini Bhargavan, 54, who sustained burns in Malaysia, was brought to Kochi on May 23 last year with the intervention of NoRKA-Roots and the Loka Kerala Sabha. Speaking to *The Hindu*, Ajith Kolassery, Chief Executive Officer of NoRKA-Roots, said that in both in-

cidents, it is suspected that the victims were working as domestic helps after being trafficked to Malaysia. They have not officially registered any complaints with the State government agencies.

The agency has borne the expense for shifting Mr. Ravi to the hospital from the airport here, while his repatriation was under the aegis of the Indian Embassy in Malaysia. He was referred for domiciliary treatment after being admitted to the MCH.

Mr. Ravi was not sure what caused the accident. He sustained the burns during a blast that occurred in the kitchen where he was working, said Remya, his wife.

## Re-examine move to scrap Elder Line, says forum

The Senior Citizens Friends Welfare Association has flayed the Union government decision to discontinue the State-level operations of 'Elder Line' (14567) helpline for the elderly. Kerala had the highest life expectancy owing to the quality of health services in the State. It also had the highest proportion of the elderly in the country. Hence, the service benefited Keralites the most.

The helpline was critical in informing the authorities concerned of violence against the elderly as well as the needs and problems of the elderly who faced isolation. Those who called the helpline were put in touch with experts and counsellors for taking prompt legal action, rescues, or rehabilitation.

This highly beneficial initiative was now set to be discontinued by the Union government at the State level from April 1 and its functioning transformed into zonal operations, with Kerala included in the south zone that will be headquartered in Telangana, the association said.

With this, the currently easy and transparent service will become very difficult to access for the elderly since after dialling 14567 they will have to select from proffered language options through phone keypad inputs and wait for directions.

Connectivity could be a problem if the traffic was heavy. Information on State-specific schemes could be difficult to come by. The future of schemes prepared with Elder Line involvement such as Sallapam and Sayampabha rapid response team were also uncertain, it said.
