

High Court sets aside order directing Collectors to take over churches

Churches involved in Jacobite-Orthodox dispute. Division Bench says HC cannot direct civil administration to take over a church in a dispute relating to the religious affairs of parish churches governed by the 1934 Malankara Church constitution

A Division Bench of the Kerala High Court on Tuesday set aside a single judge order directing the District Collectors of Ernakulam and Palakkad to take possession of six churches involved in the dispute between the Jacobite and Orthodox factions of the Malankara Church.

The court had in 2024 upheld the single judge's directive to the District Collectors of the two districts to take possession of the six churches under the control of the Jacobite faction. The single judge's order was passed on a contempt petition dismissing an appeal filed by the Chief Secretary and the District Collectors concerned. Subsequently, the State filed an appeal in the Supreme Court, maintaining that the directive of the High Court to the District Collectors to take possession of the churches was beyond the contempt jurisdiction of the High Court.

Additional Advocate General submits that attempt to take over churches can lead to law and order problems

The apex court then set aside the High Court judgment and remitted the matters to the Division Bench of the High Court, directing it to decide the controversy afresh after hearing all the parties concerned. The Additional Advocate General submitted that an attempt to take over the churches could lead to law and order problems

and even result in loss of human lives.

Court limitation
On Tuesday, the Division Bench held that the High Court cannot direct the civil administration to take possession of a church in a dispute relating to the religious affairs of parish churches governed by the 1934 Malankara Church constitution. In appropriate cases, when repeated disobedience of the decree passed by the competent court had resulted in a law and order situation, the High Court, being the constitutional court, can render justice by granting police

protection to ensure there were no law and order issues in the conduct of religious services and other affairs in the said church in accordance with the 1934 Constitution. It would be an abuse of process for a writ petitioner to approach the High Court under Article 226 of the Constitution of India seeking a writ of mandamus directing the police authorities to protect his claimed possession of a property without first establishing his possession in an appropriate civil court, the Division Bench of the court observed and set aside the single Bench order.

Supreme Court adjourns Nimisha Priya case sine die

The Supreme Court on Tuesday adjourned petitions filed on behalf of Nimisha Priya - a nurse from Kerala incarcerated and facing execution in Yemen for the murder of a local man - sine die until any fresh development comes up.

A Bench headed by Justice Vikram Nath was told by Additional Solicitor General Vikramjit Banerjee said there has been no fresh progress to report to the court. Senior advocate Raghenth Basant and advocate Subhash Chandran, appearing for the family of the nurse, also sought an adjournment while noting that the interventions of the Supreme Court has

helped to save the life of the nurse. The Bench kept the case pending without giving a future date of hearing, saying the petitions would be listed if an application is filed in the future signalling any new turn of events concerning the nurse. In October last year, the court had been informed that a new mediator had stepped in to facilitate discussions with the victim's

family members for payment of blood money, permissible under Sharia law, in return for a pardon. The execution, which had been reportedly slated for July 16, 2025 had been postponed following diplomatic interventions by the Indian government and efforts by Kathanapuram A.P. Aboobacker Musliyar, Ms. Nimisha Priya from Palakkad was sentenced to death by a Yemeni trial court in 2020 for the murder of her Yemeni business partner. Her appeals were subsequently dismissed by the appellate courts in Yemen. "Her only child, a 12-year-old girl, is living in a convent. Her mother is a domestic helper in Ernakulam and her husband is an autorickshaw driver," a petition on her behalf had stated.

Vote against LDF, says ASHAs' forum

The Kerala ASHA Health Workers Association (KAHWA) has urged voters to deliver a verdict against the LDF government in this Assembly election, accusing it of continuing a vindictive attitude towards ASHAs who had waged a nine-month day-and-night protest demanding basic labour rights. The demands raised by ASHAs were totally just, as they sought minimum wages, retirement benefits, and pension, which were promises that had been part of the LDF government's election manifesto in the 2021 Assembly election. However, the government responded to the agitation in an undemocratic

and anti-worker manner, the KAHWA said in a statement here on Tuesday. It said that after their day-night strike over 266 days, they managed to get a nominal increase in honorarium by ₹2,000 in two phases. The KAHWA said that the government, however, refused to give them retirement benefits. It alleged that though the government agreed to withdraw the conditions attached to the honorarium, other provisions were being invoked so that ASHAs continued to receive a lesser amount as honorarium. The KAHWA stated that the government was authoritarian and anti-working class and that it did not deserve to be returned to power
