With reference to the above it is informed that you are advised by the Kerala Public Service Commission, Pattom, Thiruvananthapuram for appointment as **Clerk/Cashier** (Part-I General Category & Part II Society Category) in the service of the Bank in the scale of pay of Rs. 20280-54720 (Revised scale of pay Rs. 31735-930/3-34525-1050/5-39775-1190/5-45725-1370/5-52575-1540/5-60275-1760/5-69075-1990/5-79025-2260/3-85805 (36)) subject to the terms and conditions prescribed by the Kerala Public Service Commission, Recruitment cum Feeder Category Rules of the Bank, Staff Regulations of the Bank, other relevant rules prescribed in the Kerala Co-operative Societies Act and Rules 1969. Accordingly, the Kerala State Co-operative Bank is pleased to appoint you in the post of Clerk/Cashier. The appointment is subject to the following terms and conditions.

- 1 The appointment is subject to the provisions of Kerala State Co-operative Bank's Recruitment Rule, Bank's staff regulation, Bye-law and Kerala Co-operative Societies Act and Rules 1969.
- 2 The appointment is made on a provisional basis in the category of Clerk/Cashier with conditions laid down in the Kerala Co-operative Societies Act and Rules 1969, and the service conditions stipulated in G.O (MS) 75/86/Co-op dated 30.09.1986 and subsequent amendments made from time to time and applicable to the employees of the Bank.



- 3 The Provisional appointment is subject to the final judgement of various writ petitions/ writ appeals including WP(C) Nos. 12542/2024, 14971/2024, 15103/2024, 16309/2026, 13676/2026, 14865/2026, 25846/2025, 24373/2025, 14717/2025, 18117/2026, 13936/2026, 14002/2026, 15759/2024, 12021/2026, 18131/2024, 20299/2026, 12531/2026, 15452/2026, 15476/2026, 15668/2026, 16679/2026, 18117/2026, WA Nos. 1424/2026, 1077/2025 and other writ petitions relating to the appointment of Clerk/Cashier through KPSC, pending before the Hon'ble High Court of Kerala and other forums if any.
- 4 The appointment will be made regular if your character and antecedents are found satisfactory. If the same are found to be adverse, the provisional appointment will be cancelled and the advice for appointment by the Kerala Public Service Commission will also be cancelled without further notice.
- 5 The advice and appointment of the Candidate is subject to Rule 3 (C) of the General rule of the Kerala State and Subordinate Services Rules, 1958.
- 6 At the time of joining duty you should produce the following documents in original.
 - a. Certificate to prove date of birth, qualification and community.
 - b. Physical fitness certificate issued by a Medical Officer not below the rank of a civil surgeon in the prescribed format.
 - c. Conduct Certificates recently obtained from two respectable persons of the locality of which one should be from a Gazetted Officer.
 - d. Relieving order issued by the concerned Organization/other offices.
 - e. In the case of candidates advised from Society quota must produce a relieving certificate which is attested by the Assistant Registrar (General), Co-operative Department/Concerned to prove that they are still working in the respective Member Society and is now relieved to take up fresh appointment for the post of Clerk/Cashier in Kerala State Co-operative Bank; at the time of joining of duty. It is also informed that the candidates who produced the required relieving certificate alone shall be permitted to join duty.
 - f) Five copies of latest passport size photographs of which two copies should be attested across by two separate Gazetted Officers in separate sheets.
 - g) Non creamy layer Certificate Issued by the competent authority should be submitted in the case of candidates belongs to backward classes. In the case of candidates whose community is also noted in the advice list, the same may be verified with prescribed Community Certificates.
 - h) Original and 3 photo copies of PAN & AADHAR.
 - i) Original and photo copy of PSC Advice.



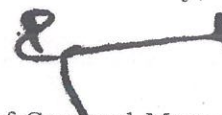
- 7 You will be on probation from the date on which you joins for duty and probationary period will be for a total period of one year on duty within a continuous period of two years. The confirmation/Increment/ promotion will be granted only on satisfactory completion of service as stated above and on achieving targets as contemplated in the clause 15 of this offer letter. If not, the probation will be extended by a period up to one year more.
- 8 You should bring a stamp paper worth Rs. 200/- (1st party- Candidate and 2nd party- The General Manager, HR Department, Kerala State Co-operative Bank, Head Office, Thiruvananthapuram) to execute a bond to serve the Bank for a period not less than five years. Violation of agreement attracts penalty fixed by the Bank.
- 9 At the time of joining duty you should furnish Cash Security Deposit of Rs. 25,000/- (Rupees Twenty Five Thousand only) which will be refunded only at the time of retirement from the service of the Bank/ resignation from the service of the Bank /termination from the service of the Bank as the case may be.
- 10 You will be bound by the Staff Regulations of the Bank and/or the rules notified by the State Government/Registrar of Co-operative Societies in accordance with Section 80 of the Kerala Co-operative Societies Act 1969, as the case may be.
- 11 You are liable to be transferred to any of the offices of the Bank within the State of Kerala.
- 12 You are advised to report for joining duty at the Head Office of the Bank at Thiruvananthapuram on or before **05.10.2026**.
- 13 You should furnish a declaration in the prescribed proforma in terms of G.O (P) No.77/2024/Home dated 05.11.2024 a copy of which is enclosed herewith.
- 14 You are bound by the provisions of State and District Co-operative Banks Self Financing Pension Scheme, 2005 under Kerala State Co-operative Employees Pension Board which is implemented for the employees of State Co-operative Bank announced by the Government of Kerala.
- 15 You are advised to canvas Rs. 25,00,000/- as fixed deposit and 100 numbers CASA (SB/CA) accounts during the first year of service for considering confirmation/ promotion/increment etc.
- 16 You will maintain utmost secrecy regarding the Bank's affairs and in respect of all transactions and affairs of its constituents and their accounts and shall in no case divulge any information which comes to your knowledge or has been prepared or collected in course of your duties unless duly authorized to do so by the Bank.



Besides the above you should also bring a service register to record your service particulars and to be kept under the custody of the Bank. **You should also bring one set of copies of attested certificates to prove age, address and qualification along with originals.**

If the above terms and conditions are acceptable, you may return the duplicate copy of this letter duly signed in token of acceptance of the above terms & conditions either within **15 days of receipt of this memorandum or before 05.10.2026** failing which the order of appointment will stands cancelled.
